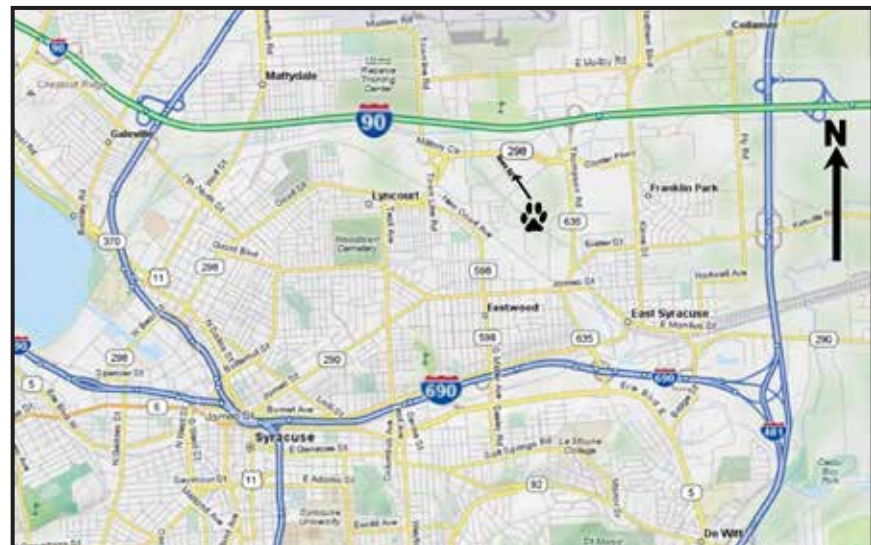
**SHOW SITE CONVENIENT TO N.Y.S. THRUWAY EXIT 35**
