**SOTC MEMBERSHIP POLICIES:** A prospective member must have trained a dog with SOTC for at least one session, or must have earned an obedience or agility title on a dog. Membership application must be accompanied by the payment of the year's dues and will be accepted at the 3rd meeting that the prospective member attends. At the prospective member's 4th meeting, the membership application will be read to the general membership. At his/her 5th meeting, the applicant will be introduced briefly. Then the membership present will vote on the application. These five (5) required meetings must be within an 18-month period and may include only one Awards Party. Individuals applying for Family memberships must apply and be voted upon separately. Junior memberships are available to those 8-16 years of age. Prospective junior members need attend only three meetings, or may be required to participate in up to three club activities in lieu of meeting attendance; and will be voted on at their 1st meeting. Associate membership is available to those members who, for reasons of health, lack of a dog or distance from the club, are no longer able to regularly participate in training. Junior, Associate, and Honorary members may not vote or hold office. Membership dues for those applying after the 1st of July will be one-half the regular fee for the membership period from July 1 through December 31. Checks should be made payable to SOTC, Inc. and should be submitted with the application to the Membership chairperson.
